# Dog Control Fees 1 July 2024 to 30 June 2025

## Definitions

**Dog to be registered** Every dog must be registered every year. Where a dog is of the age of three months or less, the application to register the dog shall be made before the dog is three months old. Failure to do so will result in an infringement notice being issued and a fine of \$300.00.

**Registration period** The period 1 July in any year to 30 June the following year.

Working dog

For the full definition, refer to section 4(3) of the Dog Control Amendment Act 2006

- Any disability assist dog
- Any dog used by the Police or any constable, Customs Department, Ministry of Agriculture, Ministry of Fisheries, Ministry of Defence, Department of Conservation, Department of Corrections, Avaition Security Service, Civil Defence Emergency Management, security guards
- Any dog kept for the purpose of destroying pests in accordance with the Biosecurity Act 1993 (proof of this must be provided at time of registration)
- Any dog kept soley or principally for the purpose of herding or driving stock
