The number of swimmers and walkers during this time also reduces significantly because it is so cold. The building is not insulated and there is no heating for the staff or in the changing rooms. In short it would be unpleasant to work at the Marton pool in the winter months and the cold and damp conditions would also make it far less appealing for swimmers. If the pool is to be opened in winter there needs to be a considerable capital investment to get the facility up to the standard of other pools which are able to open in winter months such as Splash Centre and Makino. I don't believe the council has allowed for this capital investment in your proposed option to keep the pool open in winter and therefore I do not support it.
