## 7 Reports for Decision

### 7.1 Creative Communities Scheme - Consideration of Applications for Round One of 2021/22

#### The Gullies Art Residency

Ms Harris advised the Committee that Ms Morrison had been in contact with Rangitikei College and the Taihape Area School to offer her space for students, as she has a visiting artist. The funding of \$5,000 from the Committee would support the residency costs for the visiting artist, who will attend several locations in the district, including schools, Te Matapihi and local galleries. Ms Harris asked



the Mayor if the artwork of the visiting artist could be displayed in Council buildings. The Mayor advised that this is possible, but that the request would need to go to staff (through Ms Gaylene Prince, Group Manager – Community Services).

The Mayor left the meeting at 3.39 pm and returned at 3.40 pm.

#### South Makirikiri School

The Committee agreed that this would be a good project for the school. They wished to partially fund it, noting that several companies (such as Resenes and Mitre 10) had provided paint free of charge for similar projects in the past.

#### 1000 ANZAC Poppies

The Committee unanimously to fund this application for the full amount requested, noting that the applicant had successfully coordinated this project in previous years.

#### Turakina Caledonian Society Inc

The Committee was happy to fund this application, noting that it was a longstanding event in the district.

#### Every Body is a Treasure Trust

While the Committee agreed that this sounded like a valuable project, there were concerns about to what degree it would benefit the Rangitikei district. The Committee felt that there was a risk that if funding was approved, they would be partially funding projects that either took place in other districts or had a national focus. The application was not clear enough to allay these concerns. The Committee advised that they would be willing to consider a new application for a later round of funding, provided that the applicant clarified how the project works and provides evidence that it will be run in conjunction with the relevant schools in our district. The applicant could also attend a future meeting (via Zoom or in person) to provide greater clarity.

### 7.1 Consideration of Applications for Round Two of 2021/22

#### 1. Annual Allocation for 2021/22

- 1.1 The annual allocation assigned to the Rangitikei District Council for 2021/22 was \$24,090.
- 1.2 Additionally, Creative NZ carried-forward the remaining funds from the 2020/21, which amounted to \$19,525.63.
- 1.3 In December 2021, Creative NZ allocated an extra \$6,142.01 for 2021/22.
- 1.4 The total funding for 2021/22 was therefore \$49,757.64, to be allocated across two funding rounds. \$11,550 was allocated in Round One, leaving **\$38,207.64** remaining for Round Two.

#### 2. Applications for Round Two of 2021/22

- 2.1 Five applications have been received for Round Two of the 2021/22 funding year, requesting a total amount of \$15,964, as below:

The plaque design worked well. The main issue has been the delay in completing the work. It became easier as researchers began to work co-operatively, reviewing each other's research and sharing ideas on content and presentation and gained confidence in their skills and abilities..

The collegial discussion and review sessions worked well and gave the researchers confidence developing their skills. However the issues of Covid, personal and work commitments and difficulties approaching or contacting family and whanau of subjects delayed the completion until June 2022. There are still some subjects where we are awaiting approval from whanau and this may mean that a second project is considered.

The research group has developed confidence in their own abilities and skills and being from diverse backgrounds there was sharing of ideas and concepts. All have expressed interest in continuing the project in some form or other.

The Subjects chosen reflect a wide range Pakeha, Maori, Chinese, Male, Female and LBGTQ.

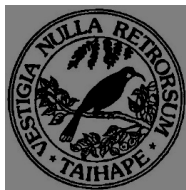

## **Porokoru Pātapu Pohe (‘Johnny’)**

**First Māori Pilot RNZAF**

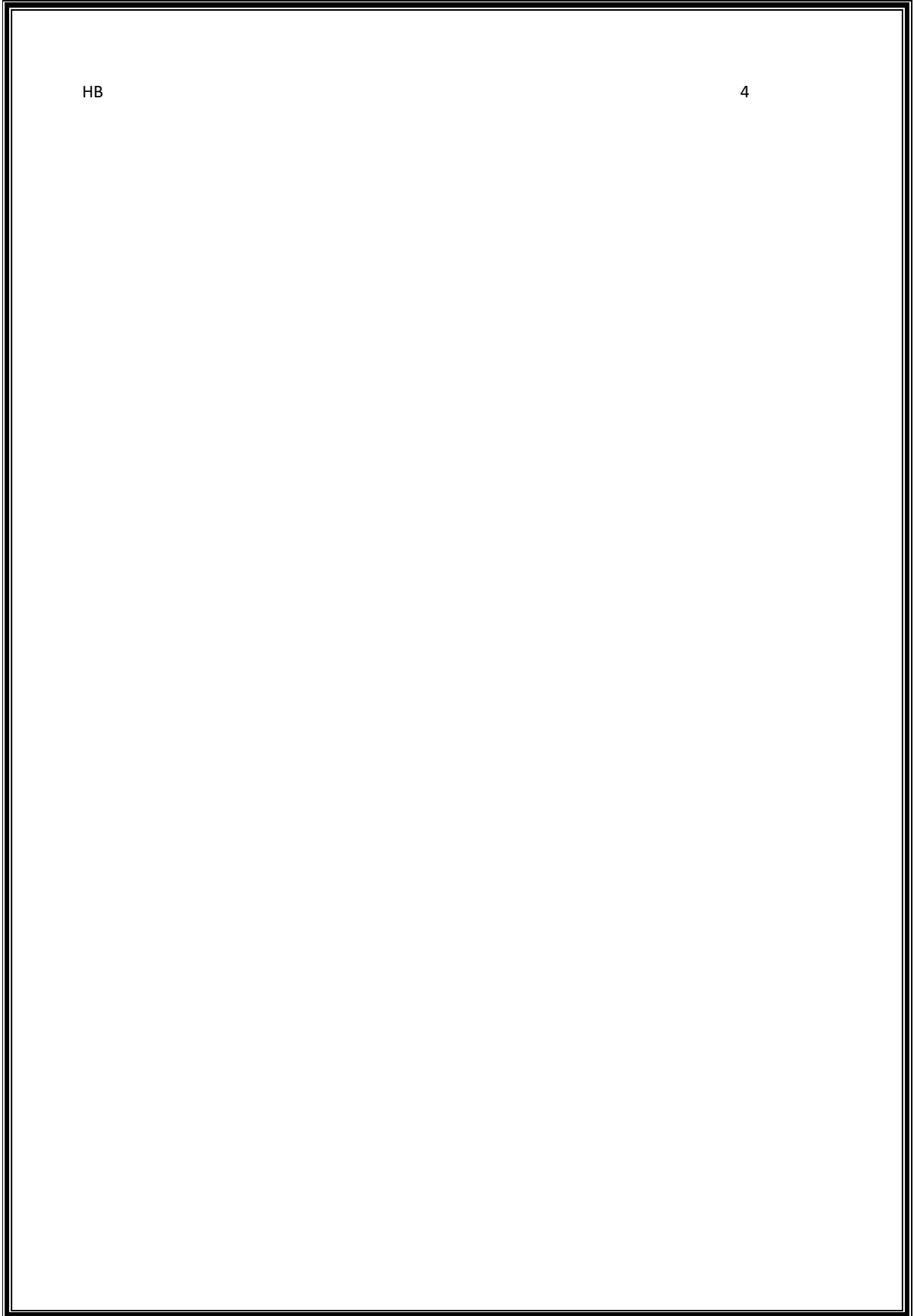
**B.1915 – D.1944**

John or ‘Johnny’ as he was often known was shot down over Germany, becoming a prisoner of war at Stalag Luft III on the 6<sup>th</sup> of October 1943. He helped plan and organise the Great Escape from Sagan in occupied Poland. After escaping and being captured, he and 51 others were executed on the orders of Hitler.

‘Johnny’ Pohe was a man of many achievements. He was the first trained Māori pilot in the RNZAF, the first Māori to fly over Europe and the first Māori instructor in the RAF. One of his operations was the Bruneval Raid. This was the one of the first successful combat paratroop drops by the Allied forces. He then completed a full tour flying Halifax bombers, and was later posted as an instructor. He sought permission to resume operational flying in 1943., which was granted

Born in Whanganui, John was the eldest son of Whatarangi and Honoria Pohe, and the great grandson of Te Oti Pohe Rangatira of Ngāti Tamakōpiri. He was raised on the family farm at Turangaarere north of Taihape, attending the local school. He went onto Te Aute College, excelling as the top academic student in 9 subjects. The family of John Pohe retain the family farm today.

# Douglas Kerr MacDiarmid

Expressionist Painter

1922 - 2020

A painter of international standing, his works are held in public and private collections from Europe to China and Africa. Douglas MacDiarmid received recognition from his home country in 1990 when he was declared a 'New Zealand Living Cultural Treasure'. His work ranged from landscapes to portraits and he was known for his varied stylistic approaches and dynamic use of colour.

Douglas was the younger son of Dr Gordon and Mary MacDiarmid of Taihape. His education started at Taihape District High School. At university in Christchurch he became part of the "The Group" where his artistic mentors included Rita Angus and Evelyn Page.

In 1946 he left New Zealand "to devour the world". Finally settling in France in 1951, he devoted his life to paint, initially as the archetypal starving artist. He exhibited frequently and from the 1960's began to make a reputation and a living. Also a published author and poet, Douglas died in Paris in 2020.





## Cecily Mary Wise Pickerill

MB.ChB. DBE

1903-1988

### New Zealand's First Female Plastic Surgeon

Cecily Pickerill specialised in groundbreaking facial surgery on newborn and young children below four years. Repair of hare lips and cleft palates became her specialty, although all types of plastic surgery were performed at Bassam Hospital in Lower Hutt; mainly on children. Her skills were recognized worldwide and it may be claimed that she was the first female plastic surgeon in the world.

Cecily and her husband, Henry Pickerill, founded Bassam Hospital to offer ground breaking surgery to New Zealand children regardless of their parents' circumstances. They both were involved in the development of plastic surgery in Australian hospitals.

Born in Taihape 3<sup>rd</sup> February 1903 to Rev.Percy Wise Clarkson, first Anglican Vicar and his wife Margaret. She attended Taihape School, then Auckland Diocesan School. Cecily became was one of the first 50 women to graduate in Medicine from Otago University.

1958 Dr. Cecily was awarded O.B.E for services to Plastic Surgery. She became a Dame in 1977. Remembering Taihape fondly, she gave a window to St Margaret's in 1988, in memory of her parents. She is remembered as ' A Pioneer Plastic Surgeon, Gardener, Gentle Lady '

The production was an excellent opportunity for every student in our school to be involved and perform on the stage and/or participate in a supporting role eg: stage crew, sound technician etc. It also provided an opportunity for our Senior and Junior Bands to perform live.

The purchased script was highly appropriate for the age of our students and allowed 34 students to have speaking roles. The organisation, with a teacher being the director could have been challenging but employing another teacher to release her to regularly to work with actors and scenes worked well.

Covid lockdown interrupted our initial performance date and meant that for 3 weeks when students were at home, rehearsals stopped and our performance dates had to be changed. On coming back to school the teacher/director and student actors went straight back into rehearsals.

Being under Alert Level 2 meant gathering rules affected our opportunity to perform to large audiences but we instead made performances by invitation only to keep within the gathering limit rules. We also recorded the performances to make it available to families on USB, seeing as many could not attend the live performances.

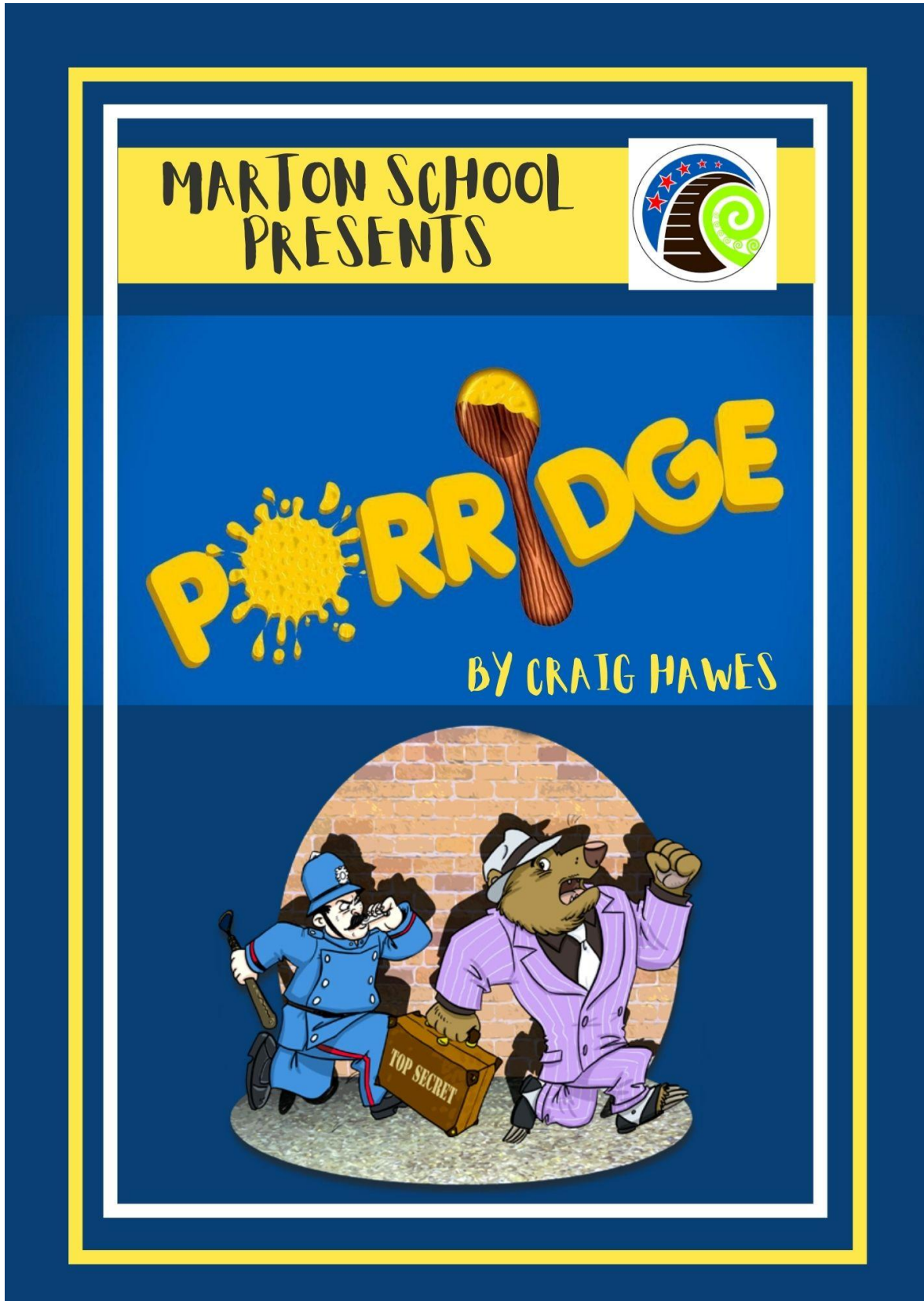
