## 6 Reports for Decision

### 6.1 Election of Chair - Creative NZ Committee

#### 1. Reason for Report

- 1.1 The Committee needs to elect its Chair for the Creative NZ Committee for the 2022 – 25 triennium.

#### 2. Election of Chair

- 2.1 Members are asked to nominate and an elect a Chair from the current membership.
- 2.2 Clause 25 of Schedule 7 of the Local Government Act 2002, which relates to voting systems for certain appointments (including the election or appointment of the deputy mayor, the election or appointment of the chairperson and deputy chairperson of a committee, and the election or appointment of a representative of the local authority), states that:
  - (2) ... a local authority or a committee (if the local authority has so directed) must determine by resolution that a person be elected or appointed by using one of the following systems of voting:—
    - (a) the voting system in subclause (3) ("system A"):
    - (b) the voting system in subclause (4) ("system B").
  - (3) **System A—**
    - (a) requires that a person is elected or appointed if he or she receives the votes of a majority of the members of the local authority or committee present and voting; and
    - (b) has the following characteristics:—
      - (i) there is a first round of voting for all candidates; and
      - (ii) if no candidate is successful in that round there is a second round of voting from which the candidate with the fewest votes in the first round is excluded; and
      - (iii) if no candidate is successful in the second round there is a third, and if necessary subsequent, round of voting from which, each time, the candidate with the fewest votes in the previous round is excluded; and
      - (iv) in any round of voting, if 2 or more candidates tie for the lowest number of votes, the person excluded from the next round is resolved by lot.
  - (4) **System B—**
    - (a) requires that a person is elected or appointed if he or she receives more votes than any other candidate; and
    - (b) has the following characteristics:
      - (i) there is only 1 round of voting; and
      - (ii) if 2 or more candidates tie for the most votes, the tie is resolved by lot.

2.3 Once the voting is complete the Mayor or Ward Councillor vacates the chair.

## 6.2 Creative Communities Scheme- Consideration of Applications for Round Two of 2022/23

### 1. Annual Allocation for 2022/23

- 1.1 The annual allocation assigned to the Rangitikei District Council for 2022/23 is \$24,090.
- 1.2 Additionally, Creative NZ carried-forward the remaining funds from the 2021/22, which amounted to \$24,094.
- 1.3 In round one the total allocation of funds was \$12,397.50
- 1.4 This brings the total funding for 2022/23 up to \$35,786.50, to be allocated across two funding rounds.

This project involved a very intricate piece of artwork painted onto plywood and mounted to the Russell St side of St Matthews School Marton.

We wanted all our tamariki and school whanau to be involved and paint parts of this where it was possible. Once Ali set the start date for painting and all the materials were purchased, we worked out a timeline and brought down small groups of students once a week to paint parts of this beautiful mural. The planning of this worked out very well, we started with our junior students painting the large areas with Ali guiding them along and teaching them different techniques and explaining why they were painting it and what it would become. The senior class got to do the same and also paint some of the more detailed parts of the mural. The center cross was a big part of this and both Ali and the school were thrilled that a school prefect got to paint this very special part of the mural. Overall, the student involvement went super smoothly and the tamariki absolutely loved spending time with Ali in her studio.

We wouldn't do anything differently if we were to do this again apart from possibly paying the artist a bit more. She put in so many more hours than she charged us for on this special mural and we are so grateful for it because it looks absolutely amazing! We went slightly

over budget, but some paints purchased were a bit too transparent unfortunately and we wanted the mural to look bright and beautiful like our little special character school.

We are still waiting for our builder to fix the mural to the wall of the building. We have it all masked out and ready to go and this should be completed in April along with an unveiling and blessing which we would love council to attend if they can.

We have had huge school and whanau participation in this project. Every child who attended school at the time has had a part to play in the beautiful mural. It reflects our school's special character and our multicultural diversity within the school.

All the block colour and some of the finer details were done by our students and school whanau over many weeks and the tamariki are so proud to show us which parts they painted.

It was amazing to be able to purchase everything for this project locally, use a local artist, local builder installing it and our special school community all participating to make it what it is.

The Mural project was a great success. The whole school from our new entrants to our seniors (25 students) and staff were involved in the process. The artist Joe McMenamin came to our school for a planning day which involved the kids drawing and talking about things that are important to them within our Taoroa School and community. The kids were so engaged and eager to share the knowledge they had learnt about the area during our recent rebranding and logo creation, a process that they were also a part of. Joe worked really well with the kids and was impressed by their enthusiasm.

On the 8th September we then had a field trip to Joe McMenamins studio in Feilding in which we took the whole school to start the painting process for the mural. The Kids loved their day out, most of them have never been to an art studio before and found it very interesting.

Following our grant application approval and further consultation with Joe McMenamin (when he came to the school for the planning day with the students) he recommended that we extend the Mural to a second (smaller) side of the shed and after some digital drafts to show how it would look and further consultation with school and board members it was agreed that this would vastly improve the look of the whole finished project.

The Mural unveiling was incorporated into Taoroa School Pet day which worked well as a

number of families had made the effort to come out to the school as well as some local community members. We also invited Gill Duncan, one of our local councilors and Taoroa resident and Leah Dehar and Maraeah Bellamy from Ruapehu Reap in Taihape to bless our new mural at the unveiling. We also invited Gill Duncan to the unveiling as our local councillor, Taoroa resident and supporter of the school.

Our proposed timeline for the project was accurate. We had great feedback from a number of the visitors (families and community) on the art work, the project and the mural unveiling day.

We have talked about the possibility of another mural on the other side of the shed in the future because it turned out so well.

Our criteria was to enable young people to engage and participate in the arts and we are very happy that we have met this within our Mural project.

Our whole school has been involved in the process, they have worked with an incredible artist to create the mural that they are all so proud of. They have learnt so much starting from the planning process to the art studio visit and actual painting of the mural. The kids were inspired by the visit to the art studio where Joe showed them how to use the paint brushes and mix colours to create depth and textures, and the process of layering the picture to create the final painting.

Most of the Students have never been in an art studio before so this was a new experience for them, they loved taking part in the painting and looking at the artwork that was on display there.
