Good Morning,

The New Zealand Defence Force (NZDF) wishes to comment on the draft Signs and Public Places Bylaw 2024, as follows:

NZDF believes appropriate recognition and reference to NZDF activities is needed in the Bylaw. Under Section 5 of the Defence Act 1990, NZDF responsibilities include the defence of New Zealand, the protection of the interests of New Zealand, the provision of assistance to the civil power either in New Zealand or elsewhere in time of emergency, and the provision of any public service. NZDF must undertake training in order to fulfil its statutory obligations under the Defence Act. Temporary Military Training Activity (TMTA) can include a wide variety of activities with no or minimal adverse effects. NZDF seeks to train in environments that have similar characteristics to that of which we may operate in which can include residential areas and rural areas. The Bylaw currently has no exemptions for NZDF or any defence activities.

Section 28 exemptions

It is noted that there are exemptions for emergency vehicles or vehicles involved in a public work, however, Defence vehicles or activities are not mentioned. NZDF requests that NZDF be included in the exemption for the reasons outlined above.

NZDF seeks the following amendments:

E) any vehicle involved in Temporary Military Training Activities or defence purposes

Section 6

To provide for the consideration for defence activities, NZDF seeks the following amendments:

In section 6.1 Any person in a public place must not: (c) Take off or land any aircraft including model aeroplanes, hot air balloon, hang glider, parachutes or similar, except in an emergency or for defence purposes;

Section 11

An appropriate exemption for TMTA and defence purposes is needed in this section to allow for defence activities, particularly in regard to this section 11.1 b) *no person may operate any vehicle to cross any water channel in any public place other than over a crossing properly constructed for such a purpose.*
